# Confidentiality in International Arbitration: Virtue or Vice?

Confidentiality is often viewed as a necessary element of international arbitration. Is this correct? Does the position differ in different countries? How important is it to the arbitral process and to parties who choose arbitration? Is it a virtue or a vice? In particular, how does it affect the publication of awards, and is their publication desirable, or possible? If arbitration continues to gain ground as a preferred method of international dispute resolution, does confidentiality mean that the development of international commercial law goes underground? And what does confidentiality mean for the existence of a *lex mercatoria*?

Following the presentation, Jones Day partner, Matthew Skinner, will comment on practical problems of confidentiality in arbitration.

## **About the Speakers**

Educated at New College Oxford and Harvard Law School, Professor Sir Bernard Rix was called to the Bar of England and Wales by the Inner Temple in 1970 and became Queen's Counsel in 1981. As a barrister, he specialised in international commercial and arbitral disputes, and also appeared before courts in Singapore and Hong Kong. From 1993-2000, he was a judge of the High Court of Justice and from 2000 to 2013 he served as Lord Justice of Appeal in the Court of Appeal. In these courts, he gave a wide range of judgments in every aspect of commercial law, banking, insurance, shipping, energy disputes, arbitration law and public international law. He now practises as an arbitrator and accredited mediator. He sits on the Court of Appeal of the Cayman Islands. He is a Professor of International Commercial Law at Queen Mary, University of London.

Professor Sir Bernard Rix has fulfilled roles as Treasurer of the Inner Temple, as chairman of COMBAR (England's Commercial Bar Association), trustee of BIICL (British Institute of International and Comparative Law), chairman of the Advisory Council of QMUL's Centre for Commercial Law Studies, and President of the Harvard Law School Association of the UK. He is an honorary fellow of New College Oxford and QMUL. Outside the law, he has long been associated with the London Philharmonic Orchestra as a board director and now as a member of its International Board, and has trod the stage in Der Rosenkavalier at the ENO.
