SUIT TO A 'T'



A former science student, Joey Ng found law school daunting. Today, she not only enjoys her work as legal counsel, but has applied her knowledge and abilities to a very different project, in the fashion business.

Like many of her peers, Joey Ng has varied interests. She enjoys fashion, has a keen interest in social issues, and always fancied trying her hand at entrepreneurship. She is also drawn to finance, which was her second major. The 2014 SMU graduate, though, chose a path through law school. "I didn't know what I was getting myself into," she laughs. "It was horrible and tough, but worth it."

Today, she considers it all good experience, and is happy in her job as an in-house counsel in the financial services sector. What's better, she has stretched her abilities and is finding that they can take her right into that happy place where all her interests meet.

#### Bee in her bonnet

Joey's recent venture is Luia, a fashion-cum-social enterprise which she set up with university friend Kylie. The hand-crafted outfits Luia sells are made by Afghan refugees.

It all began when Joey's mother-in-law returned from a trip with several items of clothing stitched by a community of asylum seekers in Malaysia. Joey's curiosity was piqued, and she set out to find out more about the organisation. It had been years since her university days, but the overseas community service Joey had embarked on in India with SMU left a strong impression. Joey was now keen to discover if she could help this group just across the causeway.

Joey soon learnt that the articles she had seen were sewn as part of the refugee organisation's tailoring project, and the entrepreneurial spark in her was kindled. Whereas previously she had neither the courage to step out nor the business skills she thought she needed, the young lawyer felt moved to take the plunge.

### Being thankful

Meeting the refugees was memorable. "It made me appreciate better where we are and the lives that we lead, compared to what's going on out there in the rest of the world and the hardships other communities face," she reflects.

Her fashion label Luia takes its inspiration from "halleluia", an expression of thankfulness—it evokes gratitude for the often-overlooked people involved in the manufacture of apparel. All profits go to the refugees, and Luia is aiming to be fully self-sustaining in time.

Looking back at her law school days, Joey draws several lessons, especially from the Legal Theory & Philosophy and Jurisprudence classes she enjoyed the most. "I was inspired to think about the nature of law and how it interacts with society," she muses. "The law can stop you from abusing someone but it's not going to force you to help someone, so there is this gap which I mull over."

Being familiar with the law has also helped in running the business, from understanding cross-border transactions and the associated risks, to preparing formal contracts, skills that Joey would have lacked if not for her time at the School of Law.

### **Buckling down**

Last year, an overnight train brought Joey and 15kg of fabric to Kuala Lumpur before communication and logistics were thrown into disarray by the pandemic. Luia was launched in December 2020, a difficult period with COVID-19 pervasive and the resultant adverse effect on retail. So far the enterprise has brought out a single capsule collection with one of the designs sewn by the refugees. In any case, the plan had always been to start small—Luia's 'micro-limited runs' have a batch size of just 20—until they fully understand their target segment and can build on it.

Joey admits she struggles with a seeming lack of impact on the community she wants to help, but takes consolation in knowing the organisation has other partners who are better positioned to help them for now.

"The most important thing is to persevere," Joey emphasises. "We want to see the fruit of our efforts."

A WISH THAT FILLED A NICHE



Chan Yuk Lun's interest in law led him to pursue a degree in it; now his goal is to make the law accessible and interesting for others, even if that means taking a different course after graduating.

"I'm willing to try new things, and am able to go with the flow," Chan Yuk Lun offers, when asked to describe himself. It is likely the reason why his website, <a href="SingaporeLegalAdvice.com">SingaporeLegalAdvice.com</a>, has taken off so successfully as Singapore's first comprehensive legal platform.



### From blog to blueprint

It was while Yuk Lun was a student at SMU that he noticed a niche in the local legal landscape that

needed filling. At the time, the country did not have a legal information website, so the law freshman decided it was time to put Singapore on par with other jurisdictions.

Prior experience creating a travel blog came in handy. Together with a friend, Yuk Lun put up a page on Blogspot and started publishing basic information gleaned from his law classes, as well as an assortment of commentaries. "I didn't have a 'hard' goal," Yuk Lun recalls. "I was more focused on how to make my website useful—making the law accessible and interesting."

That was in 2011. By the time Yuk Lun graduated, his blog was hosting 27,000 visits a month, and making a very modest income. It opened his eyes to the possibilities.

### A case for entrepreneurship

Yuk Lun opted for the path less trodden, and <a href="SingaporeLegalAdvice.com">SingaporeLegalAdvice.com</a> was incorporated in 2014, becoming sustainable within a year. The site grew



from a simple information portal into an all-rounded platform—"Singapore's Everyday Legal Platform," as the landing page proclaims. As a one-stop legal business, it offers both service and outreach, enabled by technology. Yuk Lun explains that "We give users information so that they can make decisions about the services that they need. We also give them details of lawyers, and they can compare prices as well."

### A WISH THAT FILLED A NICHE

The entrepreneur does not see his choice of career as unorthodox for a law graduate. He may not be practising as a lawyer, but his vocation is firmly grounded in the field. In bridging lawyers and clients with low-cost solutions and services, he is assured of being relevant—"feeling useful," he calls it— even if he has little time for himself and earns less than some of his peers.

In 2017, Yuk Lun was named in Asia Law Portal's list of 30 people to watch, but it is still the "little moments" that count for him, such as when users commend the portal. Deep in his heart, is the satisfaction of seeing what he had in mind come to fruition.

#### An open trail

The 32-year-old and his company often make an appearance in the media, whether it is The Straits Times, Money FM 89.3 or Mothership. With the boost in <u>SingaporeLegalAdvice.com</u>'s profile came a rise in users: these days they number in the hundreds of thousands. There is an Instagram account too, which has some 40,000 followers.

The challenge, Yuk Lun says, has evolved from getting lawyers on board to remaining relevant to users. To that end, he is developing new formats for interacting with people, experimenting and redesigning as he goes along.

He may not be practising as a lawyer, but his vocation is firmly grounded in the field. In bridging lawyers and clients with low-cost solutions and services, he is assured of being relevant— "feeling useful," he calls it— even if he has little time for himself and earns less than some of his peers.

"The Asia-Pacific region has seen much legal innovation in recent years," he notes. He is keeping an eye open for opportunities to grow in the zone. One thing is certain, though: Yuk Lun will go with the flow when the chance comes.

"I guess one lesson from the COVID-19 pandemic is that if you really want to do something, then you should before it is too late," he says wryly.

**BEING A WOMAN IN LITIGATION** 



The aggressive climate of litigation may appear incompatible with the soft power of a woman in the legal profession, but Lee Chia Ming, Clare believes that women can more than hold their own in the arena.

"By the time people come to us, usually their house is basically on fire," Clare states. "Our clients are people with problems and I've always been keen on problem solving. It's a good fit. It's what keeps me going."

Now an Associate Director at Ascendant Legal LLC (which is in a formal law alliance with international firm Norton Rose Fulbright LLP), Clare has specialised in commercial litigation and international



arbitration since she graduated from SMU in 2013. She is also an adjunct lecturer with SMU.

### A female lawyer's journey

Although litigation immediately conjures images of the sharp cut and thrust of the courtroom, Clare considers some of her strongest skills to be of a very different kind: empathy and patience. While legal expertise, rigour, and discipline are undoubtedly critical, Clare shares that it is learning to understand people at a deeper level that often helps her to identify the real motivations and problems, earn the client's trust, and secure the client's interests. Indeed, she often reminds junior lawyers and her students that lawyering is ultimately "deeply human".

Clare firmly believes that being both a woman and a lawyer comes with unique advantages. For example, she shares that her sensitivity and intuition has often helped her to grasp how to say and do the right thing at the right time and in the right way. She points out that it is often the soft skills that help to get things done.

On the other hand, being a woman in the field can mean facing subtle biases.

She prefers to channel her focus into doing good work that makes an impact. To her it is simple: "If you are good at your job, you can make someone else's life better—whether it's your boss's, your colleague's, or your client's."

### **BEING A WOMAN IN LITIGATION**

"Even now, when I walk into court with a male colleague, people assume he is the lead counsel," she laments, although the petite lawyer also jokes that it could be "more of a height problem".

#### Role models

Indeed Clare relates how, when she was a junior lawyer in the courtroom, she observed that all the juniors were female whereas all the lead counsel were male. Discouragement turned to inspiration, however, when she saw Justice Debbie Ong on the bench. "That was such a great encouragement," she recalls. She considers herself fortunate to have met other women lawyers along the way who cooperate, support, and mentor one another: "It makes a big difference to the journey."

Clare also points out that one can find mentors and inspiration in both male and female lawyers. "I have always had good role models," she reflects. From these role models she learned from early on that it is important not just to win but to win in the right way.

### Carpe diem

At the end of the day, Clare is conscious not to give in to pressure to fit others' notions of what a woman litigator ought to be like. She prefers instead to channel her focus into doing good work that makes an impact. To her it is simple: "If you are good at your job, you can make someone else's life better—whether it's your boss's, your colleague's, or your client's."

Finally, what does this accomplished lawyer wish she knew back in her law school days? To this, Clare quips: "That no one ever died of embarrassment!"

THE LAW IN THEIR OWN HANDS



Tell a local law student to dream big, and visions of Singapore's Big Four firms tend to float up. For some, though—like Wilbur Lim and his partners—that castle in the sky takes the form of their own firm, run under their own rules.

To start one's own boutique firm while still in their youth takes some derring-do, but the slew of honours that has followed <u>WMH Law Corporation</u> in just its first five years of existence proves that gumption has its reward.

#### Firm friends

Wilbur Lim and Mark Lee (LLB, 2012), the two joint managing directors of WMH Law Corporation, met in their first-year project group at SMU's Yong Pung How School of Law. Straight off the bat, the duo discovered a common outlook. They were full of ideas, as youth tend to be. They dreamed about starting their own practice, about how cases could be handled. They shared a strong belief in legal technology and more transparent fees for clients. They certainly wanted to engage in pro bono work.

The dream never faded, even while they worked in the same Big Four law firm after graduation. Wilbur credits the mentorship he received there for what he knows about practice and professionalism, skills he soon put to use.

### Finding a foothold

Together with Hazell Ng, another young lawyer at the firm, Wilbur and Mark established WMH Law Corporation as soon as they were able to; they were all still in their twenties. "When I applied for the exemption, we were told that we were the youngest to have done so," Wilbur recalls.

Their small rented office with its single phone line was in High Street, across from the Supreme Court, and where the Attorney-General's Chambers used to be—an association the self-proclaimed history junkies could not resist. "We were starting from zero," Wilbur recounts, "but it has been a very rewarding journey."

### A focus on community

Right off, they knew they wanted to effect change, and that pro bono work would be part of their raison d'être. The firm took up many such cases, but "reality set in" as the company grew. For now, they have scaled back and are trying to find a balance, but devoting more time to pro bono work is still very much a priority in future plans. The team keeps itself involved with the Criminal Legal Aid Scheme, the Community Justice Centre and Justice Without Borders, where they feel they can impact lives.

"One of the things that I am most happy with is that for several consecutive years we've been nominated as a finalist for Corporate Citizenship," Wilbur says. The Thomson Reuters' Asian Legal Business (ALB) shortlist usually boasts large international law firms, so for his small company to be counted is something the founder is especially proud of.

#### First flush of success

The 33-year-old was himself a finalist for ALB's SE Asia Young Lawyer of the Year Award and firmly on the ALB's Asia 40 Under 40 watchlist, barely a year after WMH Law Corporation was set up in December 2016

The firm has since become a regular in the ALB SE Asia Law Awards, as the finalist in a whole host of categories from Dispute Resolution Boutique Law Firm of the Year and Rising Law Firm of the Year, to

Matrimonial and Family Law Firm of the Year, Medical and Healthcare Law Firm of the Year and Transactional Boutique Law Firm of the Year.

More recently in 2021, the firm was selected as a finalist for the two top law awards: Singapore Law Firm of the Year, and Singapore Litigation Law Firm of the Year. The contenders for these two categories are traditionally the largest local firms and joint law ventures.

In these first few years, WMH Law Corporation has already tripled in size as well as in revenue; it has also boosted its regional capabilities. Its story is just beginning, though; Wilbur and his partners are still young, and still full of ideas.

### **CONTINUING THE LEGACY OF** DR YONG PUNG HOW











On 11 April 2021, our law school attained a major milestone in being renamed the Yong Pung How School of Law, in honour of the former Chief Justice Dr Yong Pung How. The renaming ceremony was graced by The Honourable the Chief Justice Sundaresh Menon as guest-of-honour and many guests including Dr Yong's family, Second Minister for Law Mr Edwin Tong SC and alumni.

SMU President Prof Lily Kong and CJ Menon recounted the special connection Dr Yong had with

SMU and its School of Law. Professor Kong paid tribute to Dr Yong's selfless service as the university's Pro-Chancellor from 2008 to 2010, and Chancellor from 2010 to 2015. She noted that "Dr Yong's commitment as founding Chairman of the School of Law Advisory Board was critical to the School during its infancy", enabling the school's reputation to continue growing today "because of the strong foundations he laid during those early years".



Chief Justice Menon shared at length on Dr Yong's contribution to the School of Law:

"Upon its establishment in 2007, around a year after he stepped down from the Bench, Chief Justice Yong took on the role of steering the Advisory Board as its Founding Chairman, and in that capacity he facilitated and nurtured close relationships between the school, the Judiciary, and the profession. I served as a member of that Board at that time, and recall being astounded by the Chief's energy and dedication to ensuring that the new school started on a solid footing with a good network of people who wished it well, and a practical presence with our Judges and lawyers.

"He later established the Yong Pung How Professorship of Law in 2007 so that the school would have the funds and more importantly, the clout to attract top legal academics in the world to teach and research here. He also identified various areas of commercial law that he thought should serve as the strategic focus for the law school and that would be aligned with the nation's own development. These initiatives turned out to be prescient, and have laid the strongest possible foundation for the law school which has gone on to establish an outstanding pedigree that well exceeds what one might have expected from an institution that has been around for just a decade and a half.

"The Chief was also very committed to doing what he could to ensure that nobody who wanted to pursue higher education would be prevented from doing so because of a lack of funds. He established the Yong Pung How Bursary in Law in 2013 to provide financial aid for less privileged students and in 2016 expanded this into a university-wide scheme. To date, more than 80 bursaries have been awarded to deserving students."



Dean Prof Goh Yihan SC spoke about the privilege of our School bearing Dr Yong's name:

"The renaming of this School to bear the name and legacy of the late Dr Yong Pung How says as much about what it represents, as where it can go... It speaks to the School's tradition of excellence, as an innovative law school that provides an academically rigorous yet practically relevant legal education... But the renaming of the School in Dr Yong's name also reinforces the School's relevance as an agent for change to shape the future, as Dr Yong had been in every organisation he was part of."

#### **Week 0: Introduction to Law**

We welcomed our freshmen last August with the second run of the Week O: Introduction to Law orientation programme. In addition to getting some early exposure to the basics of legal analysis and research, our students also had the privilege of hearing from several practitioners, including alumni.

In a panel titled Tomorrow's Lawyers, we were privileged to have an all-alumni panel comprising Kimberly Tan (LLB, 2011), Liu Xuanyi (LLB, 2016), Nicholas Poon (LLB, 2011) and Sarah Ong (LLB,2011). They shared about the various career pathways in law and their personal experiences in legal practice. In another panel titled Lawyering for Good, established legal practitioners and Ruby Lee (SMU Pro Bono Centre) shared how doing good can be part and parcel of the lawyer's vocation and their individual journeys in lawyering for good. The final panel What is Law was co-facilitated by Assoc Prof Tan Seow Hon and alumnus Asst Prof Kenny Chng (LLB, 2012).

### **LLM Programme**

In August 2021, our school also welcomed its largest ever batch of new LLM students hailing from 12 countries across the globe. In the virtual orientation, LLM Programme Director Assoc Prof Zhang Wei welcomed the new cohort, while LLM Alumni

President Teo Xiang Zheng (LLM, 2014) related his experience and insights on the programme.

Our LLM students are grouped under 3 tracks, namely, the LLM in Cross-Border Business and Finance Law in Asia, the Dual LLM in Commercial Law (Singapore & London) and the LLM in Judicial Studies. Numerous LLM courses, such as Law of Mergers & Acquisitions and Financial Regulation in Asia, are tailored for business and commercial law practitioners. ### PhD in Law, Commerce and Technology

We are launching our inaugural interdisciplinary PhD programme: a PhD in Law, Commerce and Technology. The programme emphasises the interdisciplinary study between law, business and technology. In particular, students can choose to specialise in either of its two tracks. Law and Commerce, and Law and Technology. The Law and Commerce track focuses on the study of legal and regulatory responses to business, commercial and financial activities. The Law and Technology track focuses on the study of legal and regulatory responses to technology developments. Both tracks are open to students working on topics involving the three-way intersection of law, commerce and technology.

#### **International Moots**

As mentioned in our last alumni newsletter, we had set a goal of reaching a combined total of 100 podium finishes across all competitions to mark the 10th anniversary of the lan R Taylor International Moots Programme. With the mentorship and coaching provided by many of our alumni, we are proud to announce that we have exceeded this target! Notable results include:

- Winning our first PAX Conflict of Laws championship (coached by **Huo Jiongrui** (JD, 2020))
- Earning our third trip to the Vis championship final (coached by Andre Soh (JD, 2017), Iris Ng (LLB, 2018), and Jayakumar Suryanarayanan (LLB, 2020))
- Winning our fourth International Criminal Court championship (coached by **Beverly Lim** (LLB, 2017) and Andrew Chia (LLB, 2019))
- Winning our fourth Asia Cup championship (coached by **Nicholas Liu** (JD, 2015))







The tally by the season's end was 102 podium finishes and, to commemorate the occasion, a 102-minute documentary, featuring the students and alumni in action throughout the course of the season, was released. Our alumni also continue to be generous with their donations to the International Moots Alumni Fund, allowing our students to compete in dozens of competitions every year and succeed at the highest level.

## COLLABORATING WITH OUR STUDENTS

### **Mediation And Negotiation**

Our alumni who have previously participated in international mediation and negotiation competitions have been collaborating with the SMU Mediation and Negotiation Club to coach students in local and international competitions and to share their dispute resolution experience.

Yong Eng Wah (LLM, 2014) coached our students in the Lex Infinitum international Dispute Resolution Competition in February 2021 and 2022. Last year, our students were ranked the top international negotiation team amongst 36 teams, as well as 2nd out of 18 mediator teams in the preliminary rounds. This year, our students advanced to the semi-finals and quarter-finals for the negotiation and mediation rounds respectively.



Under the guidance of **Sim Wei Qing** (LLB, 2021), **Chye Shu Li** (LLB, 2021,) and **Dhiraj Chainani** (LLB, 2015), our students were ranked 7th in the 2021 Australian Disputes Centre – International Chamber of Commerce's Asia-Pacific Commercial Mediation Competition in September 2021.

**Dhiraj Chainani** (LLB, 2015) coached our JD students who emerged as champions for the first time in the national round of the International Negotiation Competition 2021. The team was ranked 6th out of 28 teams from 19 countries in the international rounds.

The team was also assisted by alumni **Audrey Koo** (LLB, 2019) and **Benedict Hoon** (LLB, 2019) during their training.

Finally, **Benedict Koh** (LLB, 2021) guided our students who emerged as Champion and 1st Runner-Up amongst 28 teams in the Negotiation and Mediation categories of the NUJS Mediation Competition in May 2021. The team also garnered two awards: Best Mediator in the Preliminary Rounds, and Best Negotiation Opening Statement. The team was also assisted by alumni **Sambhavi Rajangam** (LLB, 2021), **Sim Wei Qing** (LLB, 2021), **Chye Shu Li** (LLB, 2021), **Seow Ling Ern** (LLB, 2021) and **Michelle Cheong** (LLB, 2021).



Our students also excelled in the International Mediation Singapore competition in 2021 (5 gold awards, 8 silver awards and 5 bronze awards) and the Asian Law Students' Association International Mediation Competition (semi-finalist). We are grateful to our alumni for devoting their time to guide our students.
