COURSE DESCRIPTION

This course provides students with a strong grounding in professional mediation, and the opportunity to develop practical skills as a mediator in domestic and cross-border settings. The stages of the mediation process and techniques for each stage are taught. Simulated role-play exercises focused on cross-border disputes are arranged to develop specialized skills as mediators.

After successfully completing this course students will:

- 1. Understand various models of mediation internationally
- 2. Be able to explain the purpose of each stage in the facilitative mediation process
- 3. Be able to demonstrate knowledge, application of ethics and skills of mediation
- 4. Be able to demonstrate conduct of a mediation process in a cross-border setting
- 5. Have the capacity to meaningfully reflect on their own performance as mediators in a structured and constructive way.

Successful and complete participation in this course may contribute towards professional mediator accreditation requirements with the Singapore International Mediation Institute (SIMI).

ASSESSMENT METHOD

- 2. Reflective Analysis on a mediation simulation as the mediator (1500 words): 50%. Due 17 October 2025, midnight 11.59 pm.
- 3. Take home exam: 30%. Due 17 October 2025 midnight 11.59 pm.

INSTRUCTIONAL METHODS AND EXPECTATIONS

This is a practice and skills focussed course that relies on case studies, role plays, skills activities and readings. It is interactive and student-focussed. Participation is imperative to learning and skill development. Each teaching and learning session will offer ample opportunity for students to participate. Students are expected to be prepared in terms of readings, engaged and self-motivated. The online sessions of equal importance as the face-to-face sessions.

Contributions should demonstrate preparedness, critical and original thinking and ability to express complex issues in a concise and understandable manner. In particular, students are expected to participate constructively in all activities including role-plays and practice sessions.
