### **CAPSULE BIOGRAPHY**

Dr. Han-Wei Liu is a tenured Associate Professor of Law at Singapore Management University's Yong Pung How School of Law. Before joining SMU, he held a tenured position as Senior Lecturer at Monash University (Australia) and previously served as a tenure-track Assistant Professor at National Tsing Hua University (Taiwan). His teaching and research span law and technology, international economic law, and financial regulation. Before academia, he practiced in financial regulation, corporate disputes, and complex commercial litigation at firms including Baker & McKenzie and Russin & Vecchi.

Dr. Liu holds a Ph.D., *summa cum laude*, Geneve Graduate Institute (IHEID), supported by a Kathryn Davis Scholarship. He earned master's degrees from Columbia Law School (Harlan Fiske Stone Scholar) and the University of Oxford (Chevening Scholar), funded through a Taiwan Government Scholarship and the British Chevening Scholarship. He also holds LL.M. and LL.B. degrees from National Chengchi University in Taipei, Taiwan.

His scholarship appears or is forthcoming in leading international law journals, including those affiliated with *Harvard*, *Columbia*, *Penn*, *Cornell*, *Georgetown*, and *Vanderbilt*, as well as the *Journal of International Economic Law*, *International and Comparative Law Quarterly*, *Journal of World Trade*, *Journal of World Investment & Trade*, *International Journal of Law and Information Technology*, *Melbourne Journal of International Law*, *Sydney Law Review*, and *UNSW Law Journal*. He has held visiting positions at Harvard Law School, Columbia Law School, National Taiwan University, and Melbourne Law School.

Dr. Liu has received various competitive research grants from government research funding agencies in Singapore and Taiwan, and advised tech firms, think tanks, and international organizations on digital trade, cross-border data governance, financial regulation, and tech transfer/export controls. His research has been cited by the WTO, the European Commission, the Australian Productivity Commission, the Australian Law Reform Commission, the Singapore Personal Data Protection Commission, the Policy Research Institute of Japan's Ministry of Finance, the World Bank, and the UN Economic and Social Commission for Asia and the Pacific. His work has also been referenced in expert testimony before the U.S. Congress, and cited by the U.S. Court of Appeals for the Eleventh Circuit. From 2022 to 2025, Dr. Liu served as Vice Chair and Co-Chair of the American Society of International Law's International Law & Technology Interest Group. He served as the inaugural Deputy Lead of the Sub-Committee on Accountability and Cross-Border Governance of the International Law Association's AI and Technology Law Committee.
