### **Capsule Biography**

Heng WANG (王衡) is a Professor of Law and the Associate Dean (Faculty Matters & Research) in Yong Pung How School of Law at Singapore Management University (SMU). He was a professor and a founding co-director of [Herbert Smith Freehills China International Business and Economic Law \(CIBEL\) Centre](#), Faculty of Law & Justice, the University of New South Wales (UNSW Law & Justice). He was also an inaugural co-director of the [Tsinghua-UNSW Joint Research Centre for International Commercial and Economic Law](#). Before that, Heng was a professor at Southwest University of Political Science and Law (SWUPL), China, and headed a leading centre at SWUPL (with the Department of Treaty and Law, the Chinese Ministry of Commerce as the partner). Heng has also served as a Fernand Braudel Senior Fellow (2019) and Max Weber Fellow (2010-2011) at the European University Institute and conducted research at the WTO Secretariat.

Heng's research evolves to explore the future of international economic governance. His current research focuses on the governance of digital transformation and foresight, including (green) AI, digital currency, sustainable development, and dispute settlement.

He strives for a holistic view including technology, finance, sustainability (e.g., environmentally responsible digitalization), geoeconomics, and other issues such as trade and regionalism.

Recently he is developing the digitalization toolkit for the United Nations Development Programme. As a member, he contributes to the World Economic Forum (WEF) AI Governance Alliance and the WEF Future of Blockchain and Digital Assets Initiative. He has been invited to speak on foresight at institutions like the Bundesbank (Germany's central bank) and the INTERPOL, including the keynote "Embrace Uncertainty for the Future" at [the World Bank FCI \(Finance, Competitiveness & Innovation\) Seoul Center's 10th Anniversary Event](#).

Heng's work has been cited in multiple intergovernmental organisation documents. He has received major grants and top research awards, including being named a research leader by *The Australian* newspaper's Research Magazine based on number of citations. Recently Heng is an investigator of [a major project related to the future of regional economic governance funded by the Australian Research Council](#).

In addition to books, he has published extensively in leading journals such as *Regulation & Governance*, and has been regularly cited and interviewed (e.g., in ABC, Al Jazeera, BBC, CNBC, Reuters, SBS, South China Morning Post, Yahoo Finance).
