### **Capsule Biography**

Jason Grant ALLEN is an Associate Professor of Law at SMU Yong Pung How School of Law. He is Director of the SMU Centre for Digital Law and an Urban Fellow of the SMU Urban Institute. Jason studied Law and German at the University of Tasmania before undertaking a LLM in International Economic Law at the Universität Augsburg as a DAAD Scholar. He began teaching at the University of Tasmania in 2010 before undertaking a PhD in Law as a Poynton Scholar at the University of Cambridge. This was followed by a year clerking for Sir Geoffrey Vos (then Chancellor of the High Court of England and Wales) and an Alexander von Humboldt Post-Doctoral Fellowship at the Humboldt-Universität zu Berlin Centre for British Studies. He was a Senior Research Fellow and Project Lead at the same institution before joining SMU.

Jason is an Adjunct (Honorary) Associate Professor at his *alma mater*, the University of Tasmania School of Law. He has been a Research Affiliate at the Cambridge Centre for Alternative Finance (University of Cambridge Judge Business School), and has held contract, visiting, or honorary positions at *inter alia* the Australian National University, the University of New South Wales, the Universität Osnabrück European Legal Studies Institute, the Weizenbaum Institute for the Networked Society, and the Queen Mary University of London Centre for Commercial Law Studies. He is a qualified NY Attorney and Counsellor-at Law (2009) and an Australian Lawyer (2011) (currently non-practising).

Jason's work explores the interface of law, economics, and emerging technology. His research has been published in leading journals as well as by the Oxford University Press and Cambridge University Press. He has been involved with a number of international legal harmonization and comparative law projects and has provided thought leadership, executive education and CPD for leading international, private and public organisations including UN bodies, central banks, and government agencies in multiple jurisdictions.
