Capsule Biography

Locknie Hsu is a full Professor and former Associate Dean at the YPH School of Law, Singapore Management University (SMU). She was called to the Singapore Bar in 1986 and practised with a Singapore law firm, working on commercial contracts, general litigation and intellectual property matters. She went on to receive a LL.M. degree at Harvard University.

Locknie specializes in international trade and investment law, digital commerce law and policy, and international dispute settlement mechanisms. She has published widely on trade and investment law, treaty dispute settlement mechanisms, arbitration law and regional economic integration issues in international journals, and has spoken at numerous international seminars and conferences. She has developed local, regional and international professional profiles through working with private lawyers, businesses, government officials and academia.

In 2020, Locknie was nominated by the Singapore Government to be one of ten international appeal arbitrators in the Multi-Party Interim Appeal Arbitration arrangement endorsed by a number of World Organization members, as part of an expert pool to hear trade dispute appeals for these members. The appointment was supported by these members and commenced in September 2020. It was renewed for a second term in 2022. Locknie was further nominated by the Singapore Government as one of five Singapore arbitrators listed under the United Kingdom-Singapore Free Trade Agreement.

Locknie has also won several teaching awards and nominations, and pioneered a cutting-edge SMU-X course, Law & Digital Commerce, which has seen successful placement of students of the course in a number of unique internships in government agencies, international law firms and global projects dealing to study a variety of digitalisation and law issues. Locknie is also a pioneering member of the Board of Editors of the International Journal of Blockchain Law and Coordinator of the Trade and Investment Group of the ASEAN Law Association. Most recently, Locknie was invited to join the Advisory Board of the prestigious Journal of International Economic Law, a leading international publication, with effect from March 2024.
