Short Biography

Locknie Hsu is a full Professor at the Yong Pung How School of Law, Singapore Management University (SMU), Singapore. She was called to the Singapore Bar in 1986 and practised with a Singapore law firm, working on commercial contracts, litigation, intellectual property and other matters before joining academia. She went on to receive a LL.M. degree at Harvard University.

Locknie specializes in international trade and investment law, digital commerce law and policy, and international dispute settlement mechanisms. She has published widely on trade and investment law, dispute settlement systems, arbitration law and regional economic integration issues in international journals and has spoken at numerous international seminars and conferences. She has developed local, regional and international professional profiles through engaging with private lawyers, businesses, government officials and academia.

In 2020, Locknie was nominated by the Singapore Government to be part of the pool of ten standing arbitrators in the Multi-Party Interim Appeal Arbitration arrangement endorsed by a number of World Organization members. Her appointment to the pool commenced on 31 July 2020 and was renewed in 2022.

Locknie has also been named as one of five arbitrators proposed by the Singapore Government for the United Kingdom-Singapore Free Trade Agreement, and as a member of Singapore's Standing List of Panel of Experts under the Trade & Sustainable Development Chapter of the same Agreement. She has also been nominated by the Singapore Government to serve as a member of the Panel of Experts under the Trade & Sustainability Chapter of the EU-Singapore Free Trade Agreement. She has also been nominated by Singapore for consideration to be a member of the Roster of Panel Chairs of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP).

In December 2024, she was elected President of the Society of International Economic Law (SIEL), a Society with a global and diverse membership comprising academics, law practitioners, officials and members of international organizations engaged in international economic law research and discourse. She is also Coordinator of the Trade and Investment Group of the ASEAN Law Association.

Locknie has won several teaching awards and nominations. In 2019, she pioneered a cutting-edge law elective course, Law & Digital Commerce, in which she arranges for students to interact regularly with business and technology professionals and regulators to explore law and digitalised

trade issues. She is a founding member of the Board of Editors of the International Journal of Blockchain Law and a member of the Editorial Advisory Board of the Journal of International Economic Law.
