Capsule Biography



Dr. Nadja Alexander is Professor of Law (Practice) and Director of the Singapore International Dispute Resolution Academy (SIDRA) at the Singapore Management University School of Law. She is described as a practical thinker and thinking practitioner. She is consistently recognised as a global thought leader in the field of mediation by Who's Who Legal.

Nadja Alexander is an award-winning author and educator, and a conflict intervention professional. In the course of her career, she has been engaged in dispute resolution work in more than 40 countries. Nadja holds honorary professorial

appointments in Australia and the United States. Many of her books and articles have been translated into various languages including Chinese, Arabic, Spanish, French, German and Russian. In 2020 her peer reviewed article, '10 Trends in International Mediation' won an award for outstanding professional article (Institution for Conflict Prevention and Resolution, New York).

Nadja's research has been used in the preparation of arguments before the Canadian Supreme Court, international arbitral awards, and in the design and drafting of mediation legislation in more than eight jurisdictions including Singapore, Hong Kong, Mongolia and Vietnam. She joined the Singapore delegation to the UNCITRAL Working Group II for the drafting of what became the Singapore Convention on Mediation. Nadja is a foundation member of the International Advisory Board of the United Nations Global Mediation Panel. She also serves as Lead Academic for Singapore to the APEC Online Dispute Resolution Collaborative Framework.
