**CAPSULE BIOGRAPHY**

Pasha L. Hsieh (謝笠天) is the Lee Kong Chian Professor of Law and Jean Monnet Chair at the Singapore Management University Yong Pung How School of Law, where he previously served as the Associate Dean for Research. He has held visiting faculty and fellowship positions at the University of Melbourne, Seoul National University, National Taiwan University, and the United Nations University Institute on Comparative Regional Integration Studies. He received his J.D. and LL.M. degrees from the University of Pennsylvania and holds a Ph.D. in Political Science from the Free University of Brussels. Prior to academia, he was a Legal Affairs Officer at the WTO Appellate Body Secretariat in Geneva and an associate at Shearman & Sterling LLP in Washington, D.C.

Hsieh's teaching and research primarily focus on international economic law, public international law, and Asian legal studies. His monograph, [New Asian Regionalism in International Economic Law](#), was published by Cambridge University Press and has been translated into Chinese and Japanese. He co-edited the book, [ASEAN Law in the New Regional Economic Order: Global Trends and Shifting Paradigms](#), also published by Cambridge University Press. His scholarly work has appeared in the *Leiden Journal of International Law*, the *Journal of International Economic Law*, the *World Trade Review*, the *ICSID Review*, and international law journals of Cornell, Michigan, Pennsylvania, and Northwestern universities, as well as peer-reviewed political science journals. The Federal Supreme Court of Switzerland, the United Nations ESCAP, and the OECD have cited his work. He has also been invited to present on trade and sustainability issues by the European Parliament, the Korea National Diplomatic Academy, the ASEAN Secretariat, and the Singapore Judicial College.

Hsieh was recently nominated to the Executive Council of the American Society of International Law, where he previously served as Co-Chair of the Asia-Pacific Interest Group. He sits on the editorial boards of the *Journal of International Economic Law* and the *Journal of World Investment & Trade*, and is a panel member of the Hong Kong Research Grants Council. He was elected to two terms on the Executive Council of the Society of International Economic Law. In addition to receiving SMU's Most Outstanding Legal Studies Teacher Award and the Lee Kong Chian Fellowship, he has won research grants from the European Commission, the Korea Foundation, the Sumitomo Foundation of Japan, and the Ministries of Education of Singapore and Taiwan.
