Capsule Biography

Prior to joining SMU, Seow Hon was an associate professor at the Faculty of Law, National University of Singapore (NUS). Seow Hon has won numerous teaching awards at the school and university levels in both NUS and SMU. Her research interest is primarily in jurisprudence. She is currently working on projects on AI, human flourishing, virtues, and the legal profession. She applies jurisprudential frameworks and theories in a wide range of contexts, varying from AI companions to unjust laws to surrogacy, abortion, euthanasia, etc. She is also passionate about how legal education influences moral and professional identities of lawyers and how it may be geared to inculcate salutary legal ideals. Seow Hon has presented papers in international conferences in Singapore, Hong Kong, Japan, South Korea, Canada, the United Kingdom, the United States, and Switzerland.

As a teacher of jurisprudence, Seow Hon seeks to make the classroom a space for students to reflect on the concepts of law and justice. Her aim is for students to discover for themselves the nature, purpose and function of law, what gives law legitimacy, how law interacts with other social phenomena, and how law's transformative potential may be harnessed, thereby facilitating the students' understanding of their future roles in the legal process.

Seow Hon studied in NUS on an OCBC Scholarship and graduated from NUS with First Class Honours. She was the valedictorian for her class, winning prizes for being the best graduate throughout her course of studies and being the top student in several other years, as well as subject prizes for obtaining the highest marks in jurisprudence, public international law, public law, and company law. She obtained an LLM and an SJD from Harvard Law School on scholarships from NUS and was also awarded the Gammon Fellowship and the Byse Fellowship from Harvard Law School. As a Byse Fellow, she taught a seven-session self-designed workshop titled "Law & morality: A critical examination of natural law theory and its relevance in a pluralist world". Her doctoral thesis, titled "Justice as Friendship: A Normative Understanding of Legal Relations", involved study in the fields of jurisprudence, ancient Greek philosophy, and the Western Christian tradition.
