CAPSULE BIOGRAPHY

I obtained my LLB (First Class) from National University of Singapore in 2007. In NUS, I was a Kwa Geok Choo scholar, an Allen & Overy scholar, the top student in various subjects including public law and jurisprudence, and captain of the Jessup moot team that came in third and won an Evans award in the international rounds in Washington DC. I then joined the Supreme Court and served as a Justices' Law Clerk and Assistant Registrar. As a JLC I assisted the Chief Justice and judges with research, hearings, judgments, and law reform work. As an AR, I heard pre-trial civil procedure applications as well as personal insolvency cases. After completing my term, I joined Singapore Management University and was awarded the Faculty Development Scheme scholarship to complete my LLM at Harvard University. I returned in AY 2010–11 and was appointed an Assistant Professor, was tenured as an Associate Professor in 2017–18, and in 2025–26 became Professor (Education). Since 2022, I have served as Associate Dean for Student and Alumni Affairs.

My primary teaching and research interests are in evidence and procedural law; I am also interested in the regulation of online spaces. I have taught courses in my primary areas in NUS and SMU since 2008, and have published in leading peer-reviewed journals in my field such as the Civil Justice Quarterly, International Journal of Evidence & Proof, and the International Commentary on Evidence. My first evidence text, *The Law of Evidence in Singapore* (Sweet & Maxwell), for which I was principal author, was released in 2016. My first civil procedure text, *Civil Procedure in Singapore* (Wolters Kluwer), for which I was principal author, was released in 2014. Other texts I have been involved in as principal author include *Halsbury's Laws of Singapore: Civil Procedure* (LexisNexis) and *Family Procedure in Singapore* (LexisNexis). My publications have been cited by the State Courts, High Court, Singapore International Commercial Court, Court of Appeal, Supreme Court of India, and UK Law Commission. I have been nominated twice for university awards for research excellence and in 2015, I was awarded the Lee Kong Chian Fellowship. In 2018, I won the University Student Life award for faculty contributions and was also nominated for the SMU-X Excellent Teacher award.

I direct SMU's Ian Taylor International Moot Court Programme, which I founded in 2010 with Eunice Chua and Lionel Leo. Now widely accepted as among the top law schools worldwide for international moots, SMU has regularly featured in the world championship finals of the largest and most prestigious competitions or "Grand Slams", including the Jessup in Washington DC (2013, 14, 22, 25), the Vis in Vienna (2015, 16, 21), the Vis East in Hong Kong (2015, 16, 22, 25), the International Criminal Court Moot in The Hague (2015, 16, 17, 18, 21, 24, 25), the Price Media Law Moot in Oxford (2010, 15, 16, 17, 18, 20, 24, 25), and the Investment Arbitration Moot in Frankfurt (2015, 17, 22, 25). These moots each attract between 100 to 800 teams from around the world annually and SMU holds the world records for most international championship final appearances (11) as well as most international championships won (7) in a single moot season. I was involved in the selection or coaching of all of these teams; many of the teams' results have been reported by both the local and international press, and many mooters go on to secure prestigious clerkships and partnerships upon graduation and some also become prolific writers of legal publications. In total (as of December 2025) SMU has emerged champions 70 times, 1st-runner-up 51 times, and 2nd-runner-up 63 times in international moot competitions, in addition to winning 391 Best Oralist and Best Memorial prizes.

My other contributions to the practice of law are through the various professional and law reform committees that I am a part of, the conducting of regular Continuing Legal Education/SMULA seminars, and research consultancy services I am occasionally engaged in for procedural, criminal, family law, and international law matters, including engagements by Senior Counsel, intergovernmental agencies, and sports associations. I am exceedingly grateful to my wife and family members for their constant support, and dedicate all things to the glory of God, whose love and patience sustain me through all that life entails.
