Stefanie Schacherer is Assistant Professor of Law at the Singapore Management University (SMU), Yong Pung How School of Law. She specialises in international economic law, with a particular focus on the intersection between international investment law and sustainable development.

Prior to joining SMU, she was a Postdoctoral Fellow at the Centre for International Law at the National University of Singapore, and a Research Fellow at the World Trade Institute (WTI), University of Bern. Her postdoctoral research was supported by funding from the Swiss National Science Foundation (SNSF). Stefanie Schacherer obtained the degrees of *Doktorin der Rechtswissenschaften* from the University of Vienna and *Docteure en droit* from the University of Geneva (*summa cum laude*) in 2019. The thesis was written as part of a *cotutelle de thèse* between the two universities. Stefanie received her LL.M. in International Business Law from King's College London (2014) and holds a Master of Laws in International and European Law (2013) and a Bachelor of Laws (2011) from the University of Geneva.

Stefanie has published widely on international investment law and sustainable development. Her monograph titled [Sustainable Development in EU Foreign Investment Law](#) (Brill Nijhoff, 2021) offers an account of the legal effects of sustainable development within the EU's international trade and investment law-making. Complementing her academic research, Stefanie has advised and provided capacity-building programmes for developing countries, including Rwanda, Burkina Faso, Madagascar, and the African Union. She has also worked with the United Nations Conference on Trade and Development (UNCTAD) in Geneva. Currently, she is an Associate with the International Institute for Sustainable Development (IISD), serves as an Advisor to the United Nations ESCAP Research and Training Network on Foreign Direct Investment, and is an elected member of the Academic Forum on Investor-State Dispute Settlement under the United Nations Commission on International Trade Law (UNCITRAL).
