Capsule Biography:

YEO Tiong Min began his academic career at the Faculty of Law of the National University of Singapore (NUS) in 1990, where he was Sub-Dean from 1996 to 1998, and Chief Editor of the Singapore Journal of Legal Studies from 2004 to 2007. He was appointed the inaugural Yong Pung How Professor of Law at the Singapore Management University (SMU) when it established its law school in 2007, where he served as Associate Dean (Research) from January 2009 to December 2011 and as Dean from July 2012 to June 2017. His research interests are primarily focussed on private international law, though he also has general interest in private law, particularly equity, remedies, restitution, and contract law. His works – published in Singapore, England, Australia, Japan, and China – have been widely cited in texts and journals published in countries including Singapore, England, Australia, Canada, New Zealand, Japan, Hong Kong SAR, South Korea, and the United States. His works have been relied upon by first instance and appellate courts in Singapore, Malaysia, Australia, England, Hong Kong SAR, and the Cayman Islands. He has been invited to deliver papers at conferences and seminars in many countries and has taught in the Summer Programme of the Hague Academy of International Law. He has been engaged as a consultant by law firms in and out of Singapore and has acted as Singapore law expert for trials abroad. He has been invited to appear as independent counsel (formerly *amicus curiae*) before the Singapore Court of Appeal in complex international commercial litigation. He has been actively involved in the Singapore legal community, having collaborated on many projects with various government departments and statutory bodies, including the Singapore Academy of Law, the Ministry of Law, and the Attorney-General's Chambers. He is subject expert in the Singapore delegation for negotiations at the Hague Conference on Private International Law. For his contributions to the theory and practice of law in Singapore, he received the Singapore Law Award in 2008, the Public Service Medal in 2011, the Academy Publishing Award in 2017, and the SAL Merit Award in 2018. He was appointed Senior Counsel (*honoris causa*), in 2012. He received the Public Administration (Silver) Medal in 2017. In 2022, he received the Partner of the Year Award from the Ministry of Law for his contributions to the work of the Ministry at the Hague Conference. He received the SMU Distinguished Educator Award in 2023.
